Membership Classifications

Youth Membership – this is for members 17 years and under. Youth memberships have no voting rights.

Single Membership – this is for members 18 years and over. Single memberships have one vote.

Family Membership – this is for a family unit. Family memberships have one vote.

Overseas Membership – this is for members that do not reside in Australia. Overseas memberships have one vote.

Derived Membership – this is for owners of horses that want to register the horse in TWO different membership numbers. You will be issued an additional membership number that is to be used for horses that are owned by ALL members on the derived membership. Members can own horses under her own membership number however, if in addition, they would like to register ownership of a horse in two memberships then they can apply for a derived membership number. This is a NEW membership number and is used when registering horses in the new derived (joint) membership. Members need to pay their individual memberships PLUS the derived membership fee each year for all memberships to remain current.

Photo Release

By participating in equestrian activities, you are consenting for you or your child/children being photographed or filmed. Release and Waiver of Liability

In consideration for being permitted to participate in any way in horse sport activities, I understand, acknowledge, and accept that:

Horse sports are a dangerous activity and horses can act in a sudden and unpredictable (changeable) way, especially if frightened or hurt.

There is a significant risk that serious INJURY or DEATH may result from horse sport activities.

I understand and acknowledge the dangers associated with the consumption of alcohol or any mind-altering drugs and agree not to drink alcohol or take drugs prohibited by law before or during any horse sports activities.

I agree to follow the directions of any event organiser or official and that any misconduct or refusal by me to follow any direction of any organiser or official can result in the CANCELLATION of my participation in the activities and my immediate removal from my horse NO MATTER where that may occur.

I agree to wear an approved helmet at all times whilst participating in driven and ridden events, as is required under the relevant rules and regulations.

I have had sufficient opportunity to read this Dangerous Activity Acknowledgement and fully understand its terms and submit it freely and voluntarily.

FOR PARTICIPANTS OF MINORITY AGE (Under 18 Years)

This is to certify that I, as a parent/guardian with legal responsibility for this participant acknowledge, understand, and accept the Waiver of Liability above and consent and agree to my minor child's involvement or participation in Horse Sport activities. I also agree to abide by the Parents Code of Conduct as it relates to Equestrian Sports.
